**Based on the queries received from the bidders through email and the discussion during the pre-bid meeting held on 09.04.2018 following are the clarifications/replies to the queries:**

<b>SECTION IN TENDER DOCUMENT</b>	<b>CLARIFICATION</b>
Appendix I Point 4	C+D+W Grade Barytes will be supplied from the stock-pile on “as is where is basis”
General	APMDC has not maintained any quality log of the samples of C+D+W Grade Barytes from the stockyard. Therefore, APMDC cannot provide any such details. However, bidders can collect the samples for their quality confirmation at their own cost. Bidders should take prior approval for the same.
Appendix I Point 6	Minimum Capacity utilization shall be 55%. However if the capacity utilization is expected to be lower than 55% for any given period (annual basis), it shall be justified to APMDC with proper rational. APMDC at its own discretion may grant the relaxation on the minimum utilisation for that particular period.
Appendix I Point 7	The beneficiation plant shall be established in and around Mangampet. The required resources including land, sources for Power, Water and any other utilities shall be identified and arranged by the JV Company.

2.26.2	The Performance Bank Guarantee (PBG) to be furnished by JV Partner to the Corporation should be valid for a minimum period of 5 years from the date of issue of LOA, and shall be extended by further periods of 5 years from the expiry of the previous PBG till the completion of the agreement with a claim period of 9 months from the date of expiry of its last validity.
General	APMDC shall provide C+D+W Grade Barytes solely for the purpose of beneficiation & sale of Barytes. Since APMDC is conducting R&D activities on the material, the successful bidder shall not create any intellectual property on the material or any components/minerals thereof. The waste material after beneficiation (tailing) shall be the property of APMDC and if demanded, the bidder shall arrange to transport the material to APMDC. However till such demand by APMDC, the JVC shall store such material at its site only.
Appendix I Point 3	For the implementation of the price formula i.e. C+D+W Price = Prevailing price of A Grade Barytes lump divided by 3.7231, the price of A Grade Barytes (4.20 Sp. Gr.) will be calculated from the prevailing price of A Grade Barytes established through e-tender cum e-auction by adjusting for the Sp. Gr. through prevailing premium rate. For e.g. the current price of A grade Barytes refers to the quality of 4.25 Sp. Gr. Therefore, the price of 4.20 Sp. Gr. will be estimated by discounting the price of 4.25 Sp. Gr. Barytes by 3.75% (i.e. 5 multiplied by 0.75% which is the current premium rate for every 0.01 change in Sp. Gr.)
2.25.1	The genuine reasons mentioned here shall include but not limited to the delay in commissioning on account of statutory clearances.
