Bidding Guide

- 1. Open the link http://www.mstcecommerce.com/auctionhome/mmb/welcome.jsp
- 2. Select the tab Minor Mineral Assam Forest.
- 3. Click on **Registration.**
- 4. Select Register as buyer.
- 5. Fill all the details and click on **Submit** button.
- 6. Go to the link <u>http://www.mstcecommerce.com/auctionhome/uplBidderDocs.jsp</u> and upload all the documents(Self Attested) as mentioned below

- 19. Submit your bid.
- 20. H1 Bidder will receive e-mail and they may approach Forest Department for further action.
